How A Public Law Firm Consolidated 15 SharePoint Environments Into One With Bonzai

Challenges

With offices on multiple continents, a public law firm faced several challenges with communication.

"We had a very complicated environment with separate SharePoint intranets across 86 locations, all in different states of degradation," said the firm's intranet manager.
